# JMJ HOLY NAME SOCIETY of Saint Mary's Church THE CONSTITUTION

# **ARTICLE I - NAME**

This organization shall be known as The Holy Name Society of Saint Mary's Church, Charleston, SC.

# **ARTICLE II - PURPOSE**

Section 1. General. The general purpose of this Society shall be:

- Promoting the spiritual welfare of the men of the parish, by encouraging and assisting them to observe the practices of the Confraternity of the Most Holy Name of Jesus, namely, the frequent reception of the Sacraments, the honoring of the Most Holy Name by active religious life, and the working against all things which offend the Most Holy Name;
- 2. Fostering the observance of the promises contained in the Holy Name pledge;
- 3. Assisting the members to participate more intimately in the life of the Church, the actions of which are Catholic Action;
- 4. Cooperating with the Holy Name Societies of the Diocese, in the execution of all works entrusted to it by the Most Reverend Bishop;
- 5. Performing such special works as are assigned to it by the Reverend Pastor.

Section 2. Specific. The specific purpose of this -Society shall be:

- 1. Receiving corporate Holy Communion on the second Sunday, in the months of October and March.
- 2. Educating the members in the works of the Lay Apostolate;
- 3. Supplying volunteers for community work., and assisting in the maintenance of that work, in the Diocese;
- 4. Fostering the Apostolate of the Catholic Press;
- 6. Encouraging the distribution of Catholic literature, and working against the display and sale of immoral literature;
- 7. Doing all other things in the Apostolate of lay action, according to the mandate given by the Most Reverend Bishop.

## **ARTICLE III - MEMBERS**

All men of the parish are considered members, upon approval by the Reverend Pastor, and will have their names inscribed in the official register of this Society.

# **ARTICLE IV - OFFICERS**

**Section I.** Ex-Officio. The Reverend Pastor who either personally or through his delegate, shall hold the office of Spiritual Director and shall be, *Ex-Officio*, an officer of this Society,

# **ARTICLE VIII - PARLIAMENTARY AUTHORITY**

Robert's Rules of Order (revised edition) shall govern in all cases, wherein they do not conflict with the rules of the Society, and of the Holy Name Societies of the Diocese.
